

## DIGITAL EXPERIENCE PROMOTION OFFICIAL RULES

## 1. NO PURCHASE NECESSARY TO ENTER OR WIN.

All entries, whether submitted through completion of the survey as described below or by mail, have an equal chance of winning.

- 2. HOW TO ENTER: Sweeps begins on September 14, 2021 at 12:00:01 AM Central Time and ends on October 4, 2021 at 11:59:59 PM Central Time. There are two (2) ways to enter, as follows:
  - (1) Via Completion of Survey: click on the link sent via email for the Digital Experience Promotion or via the link on broadway.bank and follow the on-screen entry instructions. Fill in all required information. You may enter only once. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
